Mode of Selection:

The Highest 1 bidder meeting the technically eligibility shall be awarded the contract. If the H1 bidder fails to execute the contract within the stipulated period EMD will be forfeited, institute may at its discretion to award the contract to the next lower bidder at the H1 price.

The firm should inspect the batteries and give offered price. The offered price should be excluding all taxes.

Terms and conditions:

- The Tenders superscripted with "Tender for Sale of Scrap Batteries" must be submitted
 in one sealed envelope as per the enclosed Bid Performa either on your letter head or
 on our Performa along with your covering letter before the last date & time for
 submission of Tenders.
- 2. Rates should be quoted for the entire stacked materials mentioned above. Part rate or conditional rates will not be considered for acceptance.
- 3. The bidder should quote the price in the Price-Bid excluding the taxes and duties. All Taxes and duties are to be paid extra, as applicable, at the time of making payment.
- 4. The full payment of the offer price must be deposited by the successful bidder within 7 days from the date of issue of the Sale Order.
- 5. The person authorized by the purchaser will be allowed to take delivery.
- 6. The address given in the tender shall be deemed to be Purchaser's address and correspondence sent on that address shall be considered to have been delivered to the purchaser. No claim will be entertained for the reason of forfeiture of the sum deposited in case the correspondence is returned back undelivered.
- 7. If any theft/ fire/damage or any type of mishappening occurs within the period of award of lot and removing of materials form SPA Bhopal premises the loss will be borne by the bidder. The Institute will not be responsible for loss, damage or deterioration of the material due to any cause, whatsoever within the said time.
- 8. The personnel engaged by the bidder for the lifting of the materials shall strictly follow the safety rules in force.
- 9. The late tender/ tenders will not be considered at all. The same will be returned to the concerned party in unopened condition.
- 10. The Institute reserves the right to cancel the tender of disposal or withdraw any lot or part thereof from the sale without assigning any reason thereof.
